LOUISBURG SPECIAL QUESTION

Shall the following be adopted?

Shall a retailers' sales tax in the amount of one-half of one percent (0.50%) be levied in the City of Louisburg, Kansas, to take effect July 1, 2019, or as soon thereafter as permitted by law, replacing the current 0.25% special sales tax at that time, with the new sales tax effective for a period not to exceed ten years for the purpose of providing funds for public infrastructure improvements which may include but not be limited to streets and storm-water improvements, pedestrian route improvements, water infrastructure improvements related to fire safety and dam improvements, as authorized by the governing body of the City of Louisburg, pursuant to K.S.A. 12-187 et seq.
